AIRLINE CELEBRATES WITH FLY FREE* TO VEGAS OFFER

(CASPER, Wyo.) — Wyoming residents have played their cards right and are cashing in as low-fare airline **Allegiant Air, LLC**, today inaugurates the only nonstop, all-jet service from the state of Wyoming to **Las Vegas**. To celebrate the new service from Casper, Wyo.'s Natrona County International Airport, the airline is bringing some very special guests: Vegas icons "**Elvis**" and a glamorous **showgirl**.
